These Articles of Agreement represent the contract under which terms of enrollment are determined.

<p><u>Financial Obligations</u></p> <p>1. I understand that once my child is enrolled, my Enrollment Fee of \$25.00 (less discount, if applicable) is non-refundable.</p> <p>2. My tuition is \$_____ per 10-week session. I accept full responsibility for meeting the tuition payments by the second week of the 10-week session and will pay in a timely manner. I understand that I will be assessed an additional fee of \$10.00 if tuition is not paid by the 2nd week of the 10-week session.</p> <ul style="list-style-type: none"> <u>TUITION POLICY:</u> If tuition is not paid by the 4th week of the 10-week session, the child may not return to class (until all outstanding balance is paid). <u>Multiple Child Discount:</u> A \$20.00 discount per month (or STAY and PLAY session) is given for two or more children from the same family enrolled in a preschool class or STAY and PLAY. 	<p style="text-align: center;"><u>Initial</u></p> <div style="border: 1px solid black; width: 60px; height: 60px; margin: auto;"></div>

<p><u>Participation Responsibilities and Parent Education</u></p> <p>1. I will make every attempt to attend the EPC Orientation prior to the start of school and the Mid-Year Parent Meeting in January. I will make an effort to attend other Parent Education opportunities held throughout the year.</p> <p>2. I will participate in the classroom as the participating parent when scheduled (either as Snack or Paper Towel Parent). If I am unable to work, I will arrange for my substitute.</p> <p>3. I will serve on a committee or on the Board to help maintain the school.</p> <p>4. I will sign up to help out at least one special event (Hayride/Fall Event, My Guy and I Fall Feast, Holiday Movie/PJ Night, Spring/Easter Event) held through the school year.</p> <p>5. I agree to participate in EPC fundraising activities to help raise funds to support the preschool and its programs. This includes the EPC 500 Festival in May.</p> <p>6. I will plan to help out at a minimum of one of the classroom cleanings held during the school year.</p> <p>7. <p><u>Health/Safety Issues</u></p> <p>1. I will provide all required paperwork, including my child's current immunization records at the Member Preview prior to class beginning. I understand that if all required paperwork is not completed and turned in by the first day of class, my child cannot begin class.</p> <p>2. I will provide results of a TB Skin Test for the family member(s) who will participate in the classroom. <p><u>Liability</u></p> <p>1. I understand that Edgewood Preschool Cooperative, Inc. does not assume accident liability. It is necessary to provide personal insurance for children if coverage is desired.</p> <p>We have read the above Articles of Agreement for Edgewood Preschool Cooperative, Inc. and do agree to abide by these, and by the regulations of the Board of Directors and General Membership. We agree to participate as full members. We also agree not to hold liable the school cooperation or the teacher in the event of any damage to or loss of property brought to the school by the child or parent.
